Applications are invited for the positions of full - time Consultant (Engineering) and Consultant (Instrumentation) on Contractual Basis at National Institute of Animal Biotechnology (NIAB), Hyderabad as per the following details:

Name of the position:

(i) CONSULTANT (Engineering)

Qualification & Experience: A Master's degree in Engineering preferably Civil/Electrical Engineering. A highly experienced Engineering Professional having a track-record of planning/handling/executing large construction plans in the capacity of a Senior Official in Govt. or Public funded autonomous organization / bodies. Preference would be given, if found equally suitable to others, to persons superannuated from the position of Superintending Engineer or higher and having functioned on position(s) in such public sector organizations with any Grade Pay in Pay-Band-IV or in Pay Band-III with Grade Pay of Rs. 7600 as per 6th Pay Commission of Central Govt. or their equivalent in State Govt. /Autonomous Bodies /PSUs etc.

Age : Not exceeding 65 years

Scope of Work:

1. Advising Director NIAB for Campus Development matters of the Institutes.
2. Providing guidelines and helping in Project Construction and Infrastructure development, liaising with local authorities.
3. Other matters relating to Campus Development etc.
4. Any other relevant task of institute assigned by Director NIAB.
5. Shouldering the responsibility of interim premises.
6. Coordinated handling of engineering related issues of different nature including non-civil works.

(ii) CONSULTANT (Instrumentation)

Qualification & Experience: A Master's degree in Science preferably instrumentation/ M.Tech. A highly experienced Professional with strong consulting and coaching abilities and having an experience of installation, handling and maintenance of instruments used in scientific organisations in the capacity of a Senior Official in Govt. or Public funded autonomous organization / bodies. Preference would be given, if found equally suitable to others, to persons superannuated from the position of Technical / Instrumentation / Scientific Officer or higher and having functioned on position(s) in such public sector organizations with any Grade Pay in Pay-Band-IV or in Pay Band-III with Grade Pay of Rs. 7600 as per 6th Pay Commission of Central Govt. or their equivalent in State Govt. /Autonomous Bodies /PSUs etc.

Age : Not exceeding 65 years

Scope of Work:

1. Assisting scientists in formulation of technical specifications and evaluation for procurement of instruments at NIAB.
2. Assisting in installation, commissioning, maintenance of instruments.
3. To train and develop to technical staff involved in instrumentation.

Emoluments:

1. Fixed Emoluments as per qualifications and experience as recommended (considering the qualification and profile of experience vis-à-vis expected duties) by the Committee and accepted by the Competent Authority.
2. The emoluments are fixed and do not have any other perks, add-ons etc.
3. The engagement is purely on contractual basis and initially for one year, which is renewable. The engagement can be terminated by giving a notice of one month from either side or by payment of one month emoluments.
4. No transport facility will be provided by NIAB.

Selection Procedure: A duly constituted Selection Committee shall select the candidate after interview of the applicants or may recommend the candidate based on the bio data received.

Application Procedure:

The interested and eligible candidates may send the application to Senior Manager, National Institute of Animal Biotechnology (NIAB), 4th and 5th Floors, Axis Clinical Building, Miyapur, Hyderabad latest by 09 March 2015 in the prescribed application form available on the website www.niab.org.in along with the copies of relevant certificates etc.. The candidates should ascertain their eligibility before applying.

General Conditions:

1. Incomplete applications and applications that are not in proper format will be rejected.
2. The above contractual engagement is open only to Indian Nationals.

Important:

1. The position is based at Hyderabad but some works may be assigned to be carried out at outstations also, as required.
2. No TA, DA etc. would be paid for attending the Walk-In-Interview.
3. In case there are substantial number of applicants, the Director, NIAB reserves the right to devise such criteria as deemed fit to shortlist the candidates for the interview. The decision of the Director, NIAB shall be final and binding on all, in this respect.
4. If none of the eligible candidate(s) is found appropriate by the selection committee with respect to merit and suitability to carry out the work, the position(s) will not be filled in this instance.
5. Selected candidate would devote full-time to the job as per Government norms and would not take other job/consultancy during his/her engagement as consultant at NIAB.
